In exercise of the powers conferred by sub-section (1) read with sub-section (2) of section 4 of the Juvenile Justice (care & protection of children) Act 2000 and all others powers enabling him in this behalf, the State Government vide Notification No.5/15/02-6SS/ 2708, dated 1.8.2006 constituted the Juvenile Justice Board for each district in the State of Punjab. Government further vide its notification No.3/15/02-6SS/ 3679, dated 31.8.2009 also extended the term of members of the Juvenile Justice Board till further orders. In partial modification of the notification ibid the Governor of Punjab is pleased to designate the Senior most Magistrate (after Chief Judicial Magistrate and Additional Chief Judicial Magistrate) as Principal Magistrate of Board in place of Chief Judicial Magistrate, empowering him to discharge the duties conferred as per Section 4 of the Act.
